More 787 woes for Boeing

Boeing faces further questions about the safety of its all-new 787 Dreamliner after a fire broke out in an Ethiopian Airlines jet parked at London's Heathrow Airport. On the same day, a Thomson Airways 787 flight to Florida from Manchester was forced to turn back after a 'technical issue' arose. The two incidents came only six months after the plane was grounded due to problems linked to its lithiumion batteries. Shares in Boeing fell nearly 7%, amid fears that the plane could be grounded 'once and for all' if the problem is found to be linked to the batteries.



The Indian government gave the green light to a project to design and build a mid-size 70-100 seat aircraft, through a special company involving state-run organisations such as National Aerospace Laboratories and Hindustan Aeronautics. The Prime Minister's office said that the civilian passenger aircraft industry was "a strategic sector where there is a need to have a presence in the long term, particularly in view of the rapid growth of our aviation sector", but failed to provide more details about the plan.

SAA averts strike - for now

South African Airways averted a strike that would have "devastated" the airline's operations, according to one of the carrier's unions after management extended an improved pay offer late last week. Two unions representing about 70% of cabin crew and ground staff suspended plans to strike over salaries, pensions and meal allowances, but said they would make a final decision this week.

Gulf 'could support up to four new low-cost carriers' Oman mulls launch of two new carriers; flydubai, Air Arabia to expand

With passenger traffic soaring in the Middle East and as the region's hubs become increasingly important for air services to Europe, Asia and sub-Saharan Africa, there could be room for up to four new low-cost carriers, according to an aviation industry expert.

Saj Ahman, chief analyst at StrategicAero Research, told *Arabian Business* that he believed there was capacity for at least four more budget airlines, with Iraq, Iran, Jordan, Egypt, Bahrain, Qatar and Saudi Arabia each in the running to support a low-cost outfit.

His comments came as the Public Authority for Civil Aviation (PACA) in Oman said it was set to award a license for a budget airline to either a domestic private company or to state-owned flag carrier Oman Air, in a bid to compete with established low-cost carriers flydubai, Air Arabia, and Jazeera Airways.

Gulf operators have been studying the expansion of low-cost services

as passenger traffic has increased throughout the region. Demand has risen 15.4% in the year-todate across the Middle East, compared to a 6% rise globally.

Oman Air is already laying the groundwork for expansion. In May, it placed an order for three Airbus A330-300s, followed by a firm order with Boeing for five 737-900ERs. Traffic has risen 17% in Oman alone, to 4.43m passengers, so far in 2013.

flydubai, meanwhile, is expected to announce at the Dubai Air Show in November whether it will go with Airbus or Boeing in a planned expansion of its narrowbody fleet by 50 more planes, in a deal pegged at some \$5bn.

Last month, Air Arabia, the Sharjah-based carrier, said it was looking at acquiring more narrow-body aircraft to grab a larger share of the Middle East low-cost market. It is understood to be looking at new-engine options from Boeing (737MAX) and Airbus (A320neo family) as well as Bombardier's all-new CSeries.

Carriers from other regions, too, have been eyeing the lucrative Gulf low-cost market. Kenya Airways said last week that it was planning to launch its own low-cost unit and was looking to expand its routes through the Gulf hubs of Abu Dhabi and Dubai.

GECAS delivers leased Airbus A320 to new customer Tianjin Airlines

GE Capital Aviation Services (GECAS) announced delivery of a leased Airbus A320 to new customer Tianjin Airlines to expand the carrier's fleet. Tianjin Airlines operates a fleet of more than 75 aircraft to some 60 destinations in China.

Silk Way Airlines orders two 747-8 Freighters

Boeing and Silk Way Airlines, a cargo carrier based in Baku, Azerbaijan, announced an order for two Boeing 747-8 Freighters valued at \$704m at current list prices. Silk Way Airlines currently operates Boeing 747-400 Freighters and 767-300 Freighters. AAR will handle the work at its Landing Gear Services MRO facility in Miami. The spares package has over 215,000 items and includes engines, propellers and undercarriages as well as a vast array of tooling and ground support equipment. Commenting on the deal, Rex Chief Operating Officer Garry Filmer said, "The acquisition of this package will bolster the already significant spares holding owned by Rex and will assure the support of the Rex Group fleet of 51 Saab 340 aircraft over its useful life of at least another 15 years. It will also lower our maintenance cost as these spares are purchased at a very steep discount from the retail value."

Etihad posts record results for second quarter and first half of 2013

Etihad Airways reported its strongest second quarter and half-year financial performances on record, reflecting continued solid growth in its airline alliance strategy and global cargo operations. The national carrier of the United Arab Emirates achieved an 8% increase in Q2 2013 passenger revenues, generating \$921m (2012: \$855m), while passenger revenues for the first half of 2013 reached \$1.8bn (2012: \$1.6bn), up by 13%. Revenue generated by codeshare and equity alliance airline partners was \$184m in Q2 2013. This was 25% above the \$147m turnover in the same period of

2012. Partnership revenue comprised 20% of the airline's total passenger revenue in both Q2 and the first half of 2013.

FLY Leasing upsizes aircraft acquisition facility to \$450m

FLY Leasing, a leading global lessor of modern commercial jet aircraft, increased the size of its aircraft acquisition facility from \$250m to \$450m. The facility's availability period has also been extended for two years, followed by a three year term out period to July 2018. The margin on the facility was reduced by 0.50% to 3.25% during the availability period. In addition, two new lenders, EverBank Commercial Finance and Scotiabank, joined the facility.

BAE Systems awarded £90m contract for Australian Hawk upgrades

The Minister for Defence Materiel for the Commonwealth of Australia awarded BAE Systems a £90m contract for the upgrade of their Mk127 Hawk fleet. Known as Project AIR5438, the upgrade to the Australian Hawk fleet will deliver an enhanced training capability and also encompass the supply of three Full Mission Simulators, RAAF aircrew/groundcrew training and support.

Erickson Air-Crane announces two contract extensions with SOCAFRICA

Erickson Air-Crane Incorporated (EAC) was awarded option period extensions with Special Operations Command Africa ("SOCAFRICA"). The option awards were made to Evergreen Helicopters ("EHI"), a recently acquired, wholly owned subsidiary of Erickson, to provide a fleet of fixed and rotary wing aircraft for personnel and cargo transport for the Department of Defense in Central Africa. The total value of the contract options is in excess of \$8m.

The airline currently has four CAE FFS: one Boeing 777, one Airbus A320 and two Airbus A330/340s. A multimillion dollar extension project is currently being undertaken at the training academy and is due for completion in early November 2013, with the first of the new FFS, an A320, scheduled for delivery later that month. The remaining FFS will arrive during the following 12 months.

- AMR Corporation released that consolidated capacity and traffic in June 2013 were 2.6% and 2.4% higher year-over-year, respectively, resulting in a consolidated load factor of 86.9%, 0.2 points lower versus the same period last year.
- In June 2013, **Copa Holdings**' system-wide traffic increased 19.5% year over year, while capacity increased 14.4%. As a result, system load factor for June 2013 was 76.9%, a 3.2 points increase

when compared to June 2012.

- Finnair's June traffic rose by 8.3% and the overall capacity grew 6.0% year-on-year. Passenger load factor improved by 1.8 points and was 83.3%.
- Frontier's total system load factor increased to 94% from 93% in June 2013, setting a new record for Frontier for the month. Frontier's total traffic decreased 18%, on a 19% reduction in capacity.
- JetBlue Airways reported

its preliminary traffic results for June 2013. Traffic increased 7.8% from June 2012, on a capacity increase of 8.0%. Load factor was 85.7%, a decrease of 0.2 points from June 2012.

- Republic Airways reported preliminary passenger traffic results for June 2013. The Company reported that traffic decreased 4% from June 2012, on a 5% reduction in capacity. Consolidated load factor increased one point to 87% from June 2012.
- **Southwest Airlines** released that in June 2013 traffic increased 2.3% from 2012, while capacity increased 1.7% from the June 2012 level. The load factor was 85.0%, compared to 84.4% in June 2012.
- UAL's June 2013 consolidated traffic decreased 0.6% and consolidated capacity decreased 2.0% versus June 2012. UAL's June 2013 consolidated load factor increased 1.2 points to 87.7% compared to June 2012.

AVITRADER WEEKLY AVIATION HEADLINES

Labour relations were solidified on July 10th, as **AJW Technique** ratified its first collective bargaining agreement with the IAMAW (International Association of Machinists and Aerospace Workers), enabling a collaborative Collective Bargaining Agreement (CBA) to be written in record time. AJW Technique now has almost 70 employees at its Montreal facility and more joining the team each week as the organisation expands to meet customer demand. This development has given a welcome start to many of the experienced technicians that live in a city so focused on aviation. Numbers of staff at AJW's new MRO are expected to push beyond 200 by the end of 2014.

The Air Line Pilots Association, Int'l (ALPA) hailed the announcement by the U.S. Federal Aviation Administration (FAA) that the agency is increasing the minimum qualification requirements for first officers (copilots) who fly for U.S. passenger and cargo airlines. The new regulations, which go into effect on August 1, reflect ALPA's efforts on several fronts and incorporate several ALPA recommendations. Directed by Congress, the Airline Safety and FAA Extension Act of 2010 called for increased minimum requirements for airline first officers. The new rule mandates that airline first officers hold an air transport pilot (ATP) certificate or the new "restricted ATP." An ATP certificate requires, among many other qualifications, that the pilot be at least 23 years old and have logged at least 1,500 hours of flight time.

The "restricted ATP" will require pilots to be at least 21 years old with:

• 750 flight hours if they are military-trained
